EDC - It's the Law - and an Opportunity

5 U.S.C. § 552 (a)(7):

(7) Each agency shall -

(A) establish a system to assign an individualized tracking number for each request received that will take longer than ten days to process and provide to each person making a request the tracking number assigned to the request; and

(B) establish a telephone line or Internet service that provides information about the status of a request to the person making the request using the assigned tracking number, including -

(i) the date on which the agency originally received the request; and $% \left(\frac{1}{2}\right) =\left(\frac{1}{2}\right) \left(\frac{1}{$
