### Strategic Intent

- Develop a Course of Action Option (COA) Paper.
- Up to 3 COA.
- Identify key objectives and corresponding short and long term goals.

### Realistic Expectations

- How much can we feasibly do with what we have?
- What could we do with 'x' amount of increase or help?
- What would it take to enlist that help in bullet 2?

### Accountability - Examine your workflow processes

- Layout your workflow process as it stands.
- Identify areas to enhance efficiencies, utilize technology and/or change your FOIA workflow process.

### Accountability

- Develop metrics that align with the workload and workflow to improve operational performance throughout the organization.

### Leadership Support

- Present these COA to senior leadership in order to determine how much of a backlog they are commitment to eliminating.
- Also, be deliberative about indicating that if this support diminishes once the backlog is eliminate another backlog is on the horizon.
